District 6 Anonymity - Motion

Motion 676 of December 2023: District 6 website committee shall create and maintain a District 6 in Area 15 YouTube channel to archive and share District 6 audio and video presentations and educational materials.

The following conditions must be met for an audio or video to be published on the YouTube channel or our District6AA.org website:

- a) No faces will be shown in videos and audio will be scrubbed for anonymity prior to posting. The committee originating the recording will review it for anonymity before it is posted and once the recording is posted, *any District 6 member with a concern may ask for a further review* by either the originating committee, the current practices committee, or ultimately appeal to the body.
- b) Anyone whose voice is heard must agree to the recording being posted.
- c) Unless the content of the presentation is produced by District 6 or one of its committees, there will be a non-affiliation disclaimer.

District 6 Anonymity Statement

In accordance with District 6 current practice, no faces are shown in our videos and audio is scrubbed for anonymity prior to publishing.

Contributors whose voices are heard have given consent to be recorded and published consistent with our terms of use.

District 6 Disclaimer Statement

Opinions expressed by the presenter are their own and do not necessarily represent the group conscience of District 6 as a whole.

District 6 Waiver - Motion

Motion 654 of April 2023: Require a waiver from all District 6 speakers who are audio recorded. This waiver may include the traditional "General Speaker Waiver," completed and signed by the speaker, or in its stead, an audio recording of the speaker giving verbal consent accompanied by an email from the speaker confirming their record and release consent. In either case, a physical or digital copy of the consent will be provided to the speaker, the District 6 Archives chair for the Archives file, and the audio recording company if applicable.

C. A.A. ENTITIES

• <u>The A.A. Service Manual</u> in the sections "Area Newsletter or Bulletins" provides guidance to A.A. entities regarding the reprinting of Alcoholics Anonymous copyrighted material. The section states:

"Local A.A. publications are permitted to reprint the Steps, Traditions, and/or the Concepts, and to *quote a phrase*, **sentence or brief paragraph excerpted from A.A. literature** such as the Big Book, *Alcoholics Anonymous*, the *Twelve Steps and Twelve Traditions*, *The A.A. Service Manual* and Conference-approved pamphlets without a prior, written request to do so. When this occurs, the proper credit line should be included to ensure that the copyrights of A.A. literature are protected. After a quotation from a book or pamphlet, the credit line should read: *Reprinted from (name of publication, page number)*, *with permission of A.A. World Services, Inc.*"
